



## MICRA CHALLENGE 2025 – REGULATIONS

### **Article 1.0 Announcements**

The Micra Challenge 2025 is promoted and organised by Ballynahinch & District Motor Club Ltd.

The main aim for the Micra Challenge is to provide low-cost competition for competitors (drivers and co-drivers) of Micra K11 rally cars (see Appendix A: Technical Eligibility Regulations). The rallies selected for inclusion in the Challenge will test competitors on a single venue race circuit, tarmac events on closed public roads and forest-based gravel roads.

In addition to the Micra Challenge which is open to all eligible cars that comply with the Micra Challenge Technical Regulations, there will be a Category for Standard Micras that also comply with BTRDA Rally First Technical Regulations — these are effectively standard cars with a maximum engine capacity of 1400cc with suspension upgrades permitted (non-canister) and upgraded differential in addition to standard rally safety modifications. Please note that Micra Kit Cars are not eligible for the Standard Micra Category. [Note that one-make tyre restrictions applicable to BTRDA do not apply to the Micra Challenge]

The Micra Challenge Coordinator shall be Gavin Campbell.

In the case of any dispute relating to the Micra Challenge it will be referred to the following panel of three Micra Challenge Stewards appointed by BADMC: David Meeke, Ray Linton, Lewis Boyd. The first named is the Chairman of the Stewards and in the event of non-availability of any of the Stewards BADMC shall appoint a replacement.

The Micra Challenge will be run in compliance with the International Sporting Code (and its appendices), the provisions of the Motorsport UK National Competition Rules and these Micra Challenge Regulations (including the accompanying Technical Eligibility Regulations).

The Challenge shall run under Motorsport UK Championship Permit No: CH2025/RALLY072

The Micra Challenge is open to those who hold a suitable Competition Licence issued by Motorsport UK or Motorsport Ireland (or Non-Motorsport UK / Motorsport Ireland Licence holders who hold a current Eligible Grade Licence with permission from their ASN) and who are fully elected members of Ballynahinch & District Motor Club.

## **Article 2.0 Eligible Events**

8<sup>th</sup> March Race & Rally Bishopscourt Stages Rally (Single Venue Rally)
19<sup>th</sup> April Circuit of Ireland Rally (Saturday only) (Closed Road Rally)
16<sup>th</sup> August Modern Tyres Ulster Rally (Saturday only) (Closed Road Rally)

4. 6<sup>th</sup> September Lakeland Stages Rally (Forest Rally)

5. 20<sup>th</sup> September Bushwhacker Rally (Saturday only) (Forest Rally)

If any of the above events fail to run on the date(s) listed above, it shall cease to be a round of this Challenge. In this case the organisers reserve the right to nominate a replacement event which will be notified to all registered competitors by email and on social media.

Organisers of qualifying events retain the sole right to select and accept entries for the event. The Challenge organisers cannot be held responsible for any competitor not getting an entry, for any reason. It is a competitor's responsibility to obtain Event Regulations and make his/her entries and it is recommended that competitors submit entries promptly.

### **Article 3.0 Scoring**

On each round all Micra Challenge competitors who are classified finishers will be allocated the following points:

•	Highest Placed Registered Driver / Co-Driver	-	15 points
•	Second Placed Registered Driver / Co-Driver	-	12 points
•	Third Placed Registered Driver / Co-Driver	-	10 points
•	Fourth Placed Registered Driver / Co-Driver	-	9 points
•	Fifth Placed Registered Driver / Co-Driver	-	8 points
•	Sixth Placed Registered Driver / Co-Driver	-	7 points
•	Seventh Placed Registered Driver / Co-Driver	-	6 points
•	Eighth Placed Registered Driver / Co-Driver	-	5 points
•	Ninth Placed Registered Driver / Co-Driver	-	4 points
•	Tenth Placed Registered Driver / Co-Driver	-	3 points
•	All other finishers	-	2 points
•	All those who start but don't finish an event	-	1 point

Additionally, the Standard Micra category will be marked separately using the same points on all events. Standard Micras will therefore be eligible for both Overall and Standard Class Awards.

Updated points tables will be emailed to registered competitors after every round (as long as they have provided an email address when registering).

For the purposes of Micra Challenge points, the following definition of Counting Events shall apply (except in the case of ties – see Article 6.0):

- 5 events run 4 to count
- 4 or 3 events run All to count
- If less than 3 rounds run, there shall not be a Challenge.

#### **Article 4.0 Awards**

The Challenge Coordinator shall email provisional Challenge results to all Registered Competitors after the final round that will become final after 7 days.

End of year awards will be allocated to the top three registered drivers and co-drivers, with the driver and co-driver with the most points being allocated first place and so on. Awards will also be presented to the top registered driver and the top registered co-driver in the Standard Class.

### **Article 5.0 Prizes**

Trophies will be awarded to the top three registered drivers and co-drivers.

Trophies will be awarded to the top Standard Category registered driver and co-driver.

The organisers may present additional awards at their discretion.

### Article 6.0 Tie-break

In the event of a tie-break between competitors for end of year awards, the place will be allocated to the competitor with the highest score on the first scoring round of the Challenge. (i.e. if Competitor A scores points and Competitor B scores less points, does not start the event or fails to finish, then Competitor A will be the winner. If A starts and non-finishes, or doesn't score, and B does not start, then A wins the tiebreak.). In the event that neither competitor competed on this event then the second round shall be considered and so on until a result is confirmed.

#### **Article 7.0 Penalties**

Should any car be found to be ineligible for the class entered on any Challenge event, or if any competitor is disqualified or excluded from the Challenge or a Challenge event for fraudulent or unsportsmanlike behaviour, or bringing the sport into disrepute, all points scored by both crew members to date may be forfeited. Additionally, any registered competitor who brings the sport into disrepute through the un-authorised use of private and/or Forest Service lands will result in the forfeiture of any points awarded (to-date) and the annulment of their registration for this Challenge.

## **Article 8.0 Registration**

Drivers and co-drivers will each be required to register separately for the Micra Challenge in advance of competing in the Challenge. Registration shall be online at <a href="https://www.Rallyscore.net">www.Rallyscore.net</a> and will be subject to a registration fee of £50. The registration fee includes one set of Challenge car decals. Points shall only be awarded for results gained after registering.

Registered competitors must also be a member of Ballynahinch and District Motor Club and they may apply to join the Club when registering on Rallyscore at the discounted rate of £10 (normally £15). This membership will be the only Club membership required to compete on all rounds of the Challenge.

Competitors must display Challenge decals clearly on the car in the locations to be specified by the Challenge Co-ordinator. Failure to display Challenge decals as directed may result in Challenge points being withheld. This will be a decision by the Challenge Stewards, based on circumstances.

## 8.1 Specific Challenge Regulations

- 8.1.1 By registering for the Challenge all competitors and their associates commit to positively promote and demonstrate the Motorsport UK's Respect Code which is appended to these regulations (Appendix B).
- 8.1.2 Where any reports of disrespectful conduct are judged to be well founded the Challenge organisers may issue warnings or require remedial actions and/or report the matter to the Challenge Stewards who may impose appropriate penalties which can include loss of Challenge points and/or race bans through to Challenge Expulsion and referral to Motorsport UK.
- 8.1.3 It is imperative that we promote the safety and wellbeing of young people and adults at risk. In addition to this all participants must be aware of their behaviour and conduct at all times and abusive language and harmful behaviour will not be tolerated. Any such incidents must be reported to the Challenge Coordinator and/or Safeguarding Officer who will also relay the report Motorsport UK. ## **Article 9.0 Publicity and Marketing**

It is anticipated that there will be marketing and promotion of the Micra Challenge using online tools and specialist publications. By registering for the Micra Challenge, competitors agree to the use of images of competing cars and competitors being used by the organisers for the promotion of the Challenge.

## **APPENDIX A: TECHNICAL REGULATIONS**

#### 1.0 Introduction

The eligibility criteria for the 2025 Micra Challenge have been derived to make the competition as open as possible and to enable competitors to make use of available equipment.

It is anticipated that a wide range of car specifications will compete together with a specified maximum engine capacity being the overall constraint on car performance.

The Micra Challenge retains the right to clarify these regulations by Bulletin (subject to NCR 4.4.1.3) in the spirit of fair competition. Competitors will be notified in writing in advance of any changes being introduced.

#### 2.0 Criteria

All Micra Challenge rally cars must meet all relevant Motorsport UK requirements for this class of vehicle and have all required safety equipment, and in addition the following criteria are mandatory:

- 1. Rally cars must be based upon the Nissan Micra K11 (approximate manufacturer date 1993 2003).
- 2. Rally cars must use a Micra K11 16v engine with maximum engine capacity of 1400cc.
- 3. Induction systems are free with the only constraint being that forced induction systems are not permitted (i.e. no turbo or super-charging).
- 4. Rally cars must use a standard K11 gearbox casing (either distributor or coil pack) but gearbox internals are free.
- 5. Limited slip differentials are free, as is the choice of crown wheel and pinion.
- 6. Front and rear braking systems are free.
- 7. Front and rear suspension systems are free.
- 8. Rally cars can be either standard track width or wide track (Kit Car specification).
- 9. Wheel diameters are free but must have a maximum width of 7 inch.
- 10. Tyre makes and compounds are free.
- 11. Bodywork may be standard manufacturer steel panels or fibreglass replacements where permitted by Motorsport UK National Competition Regulations.
- 12. All vehicles must comply with Motorsport UK Category 1 logbook/ vehicle passport requirements.
- 13. Side and rear windows may be replaced with polycarbonate in accordance with Motorsport UK guidelines.

## 3.0 Technical Scrutiny

A Motorsport UK eligibility scrutineer will be appointed by the Challenge Coordinator and will have the authority to inspect all rally cars at any counting round to ensure compliance with the Micra Challenge Eligibility Criteria including the Standard Micra category.

## 4.0 Eligibility Appeals

Competitors may appeal the suitability of another competitors' vehicle subject to adherence to standard Motorsport UK procedures for such events (NCR 2.7.6).

In the event that a competitor's vehicle is found to not be in compliance with the Micra Challenge Technical Criteria the competitor will have all points for the season removed and they will therefore be ineligible for end of season awards.
